11. Prop 13: Split roll California residents, registered voters

In 1978, California voters approved California's Proposition 13. Under Prop 13, residential and commercial properties are not reappraised each year to keep up with current market value. Instead, any increase in the taxable value of the property can be no more than 2 percent per year, as long as the same owner has the property. When a property is sold, the new owner is taxed on the full current value of the property in that year. From that new market value, the 2 percent cap then limits tax increases every year after that.

Some lawmakers have suggested changing Prop 13 so that the tax cap is removed for commercial properties only. This would let all commercial property taxes increase along with market value each year, not just when a business property is sold to a new owner.

Opponents of this plan are concerned about the effects of higher property taxes on businesses in California. Supporters say that higher taxes on commercial property would reduce the need to increase taxes on individuals. These additional property taxes would go directly to California cities, counties, and school districts.

With this plan, sometimes called a "split roll," the tax cap would be left in place for homeowners.
