Hydraulic fracturing or "fracking" is a technique used to inject fluid thousands of feet underground to create tiny cracks in rocks that allow oil and natural gas to be brought more easily to the surface. Water and sand comprise approximately 98-99% of the fluid used in hydraulic fracturing with the remaining 1-2% consisting of various chemical additives.

Hydraulic fracturing has been largely responsible for the recent substantial growth in U.S. oil and natural gas production and some studies have suggested that it could raise billions of dollars of tax revenue while creating thousands of jobs in California.

However, <u>critics have expressed concerns about potential harms</u> they believe it may cause to the environment including excessive water usage, possible risk of leaking chemicals into the groundwater, and potential effects on the climate.
