

# Game Concept and Introduction

### Intro to the Game

- 1.5 sided game, 2 moves
  - Adversary played by the game team
  - Play in Move 1 linked to Move 2
  - Discussion about follow-on implications in plenary
- Hypothetical crisis with hypothetical states, capabilities, and threats
- Group will separated into teams of five (or more):
  - Executive
  - Minister of Defense
  - Minister of State/Foreign Minister
  - Economic Advisor
  - Military Strategic Commander
  - National Security Advisor (if there are 6 players)

# How to Play the Game

- Go to groups
- Players determine their roles
- Review game materials
- Teams develop a Strategic Plan and a Military Strategic Plan
  - 1. Describe your overall plan, course of action, desired end state
  - 2. For strategic plan, select appropriate response actions
  - 3. For military strategic plan, describe military plan in detail and select appropriate response actions
  - 4. Select nuclear orders
- Plan for one week of orders for both the strategic plan and the military strategic plan
- After the group finishes their response plan, take individual surveys

# **Crisis Scenario Scene-Setter**

- Geography
  - Maritime nation, primarily coastline with a shallow interior
  - Interior is primarily flat agricultural lands and forests
  - Extensive mountain ranges secure the land borders
  - Gray Island located 1875km off the coast of Our State
    - Equidistant between Our State and Other State
    - Territory evenly divided between Our State and Other State

### • Population:

- Roughly 70 million
- Approximately 70% lives within 100km of the coast
  - 35% of the total population in major coastal urban areas.
- Gray Island is a heavily populated part of Our State
  - About 10% of the population of Our State



#### • Economy

- Advanced industrial state (GDP top 5 globally)
- Diversified economy with high-tech service industry, IP intensive manufacturing, and mineral extraction
- Trade dependent: relies heavily on maritime trade
  - Exports= 30% of GDP
  - Imports components for smart munitions

### Diplomacy

- Non-permanent member of the UN Security Council
- Member of World Bank, IMF, World Trade Organization
- Strong diplomatic presence world wide
  - Neighbors and international community maintained neutrality on Gray Island issue

### Intelligence

- Robust foreign and domestic intelligence capabilities
- Integrates ground, air, and space sensors for imagery, radar, infrared, and signals intelligence



- Military Conventional Capability:
  - Regional, high-tech power
  - Strong conventional capabilities within region
  - Blue-water Navy:
    - Two nuclear-powered aircraft carrier groups w/multirole destroyers
    - Three amphibious assault groups
    - 4th and 5th generation aircraft
    - Nuclear power attack submarines
  - Air Force/Air Defense
    - Modern IADs with shoot-down ranges of 50-75NM
    - 4<sup>th</sup> and 5<sup>th</sup> generation stealth fighters/bombers
  - Army/Special Operations
    - Highly trained, combined arms force, equipped with high-tech long range fires
    - Trained and equipped for amphibious operations
    - Experienced Special Operations Force (SOF) capability



- Nuclear Capability:
  - Strategic and Tactical nuclear capability
    - Nuclear powered ballistic missile submarines (SSBNs)
    - Stealth strategic bombers
    - Land based strategic missile capability
      - Fixed and mobile launch facilities
      - Medium and intermediate range missiles
    - Digital nuclear command, control, and communications (NC3)
    - Early warning of attack from air/space network of intelligence sensors



- Cyber and Space Capability:
  - Cyber
    - Offensive
      - Can target military networks/systems
      - Can target civilian critical infrastructure
      - Can create reversible or long-term effects
    - Defensive
      - · Integrated into military
      - Must surge reserve capabilities to protect civilian targets
  - Space
    - Domestically operated global positioning system (GPS).
    - Robust satellite communications for military/nuclear command & control
    - Satellite ISR essential for early warning of enemy nuclear launches
    - No anti-satellite capabilities





- Similar economic, diplomatic, military, nuclear, cyber, and space capabilities to Our State
- Speak the same language

### Crisis Scenario

- Ongoing disputes with Other State over Gray Island and within the Gray Seas
- Both states claim sovereignty over Gray Island with multiple conflicts over the territory (none decisive)
  - Gray Island is resource rich (fisheries, oil, strategic ports)
  - Strong historic ties to Gray Island for both Our State and Other State
- De-facto demilitarized zone has developed on Gray Island
  - Separates half of island controlled by Our State and other half controlled by Other State
- Tensions spill over to maritime skirmishes, vessel seizures, and port sabotage
- Gray Island approaching 20th anniversary of last major conflict which led to current uneasy peace

### **Crisis Situation**

- Crisis Day 1:
  - Other State announces their intention to reunite Gray Island
- Crisis Day 5:
  - Other State orders the activation of reserve forces on mainland
  - Imagery suggests Other State is mobilizing amphibious forces
- Crisis Day 6:
  - Reports of skirmishes on the demilitarized zone
  - Potential special operations sabotage operations and cyber attacks on Gray Island infrastructure
    - Communications to and from Our State and Gray Island increasingly difficult
    - Transportation (airports, rail, and ports) all reporting challenges using IT systems
- Crisis Day 7:
  - Intelligence suggests Other State may be pre-positioning a mobile nuclear missile capability on their portion of Gray Island




# Intelligence on Other State

- Other State's Objectives:
  - Preserve government stability
  - Maintain territorial integrity
  - Gain control of Gray Region
  - Minimize harm to Other State's economic, reputational, and military capabilities
- Other State believes it can deter Our State from retaking Gray Island by prepositioning nuclear forces on Gray Island
- Other State regime leaders are under domestic pressure to "reunite" Gray Island with almost complete support from the population to take Gray Island by any means possible
- Other State nuclear forces on alert with SSBNs at sea and nuclear armed bombers in patrols above Other State
- Other State is willing to use nuclear weapons if:
  - Other State conventional forces at risk of defeat
  - Other State regime stability at risk
  - Other State perceives risk to its nuclear arsenal
  - Other State perceives no other way to hold Gray Island



# Crisis Situation: Diplomacy

- Our State diplomatic mission remains in Other State
  - Destroying sensitive materials in case of a raid
- UN Security Council is holding an emergency meeting
- Other State claims Our State was using nuclear blackmail to hold Gray Island and would no longer be deterred by Our State
- No indication of Our State or Other State allies involvement in crisis
  - International community so far maintaining neutrality in conflict
