[Joseph R. Antos](#) is the Wilson H. Taylor Scholar in Health Care and Retirement Policy at the American Enterprise Institute (AEI). He also is a commissioner of the Maryland Health Services Cost Review Commission and an adjunct professor at the Gillings School of Global Public Health of the University of North Carolina at Chapel Hill. Before joining AEI, he was assistant director for health and human resources at the Congressional Budget Office (CBO) and held senior positions in the US Department of Health and Human Services, the Office of Management and Budget, and the President's Council of Economic Advisers. He also has extensive experience as an adviser to the US Agency for International Development, the World Bank, and governments in Europe and Asia. Antos has written, lectured, and testified before Congress on the economics of health policy, including Medicare and broader health system reform, health care financing, health insurance regulation, and the uninsured. He is the editor with Alice Rivlin of *Restoring Fiscal Sanity 2007: The Health Spending Challenge* (Brookings Institution Press, 2007). He is past chairman of the Coalition for Health Services Research, a member of CBO's panel of health advisers, and serves on a variety of professional boards. He earned his PhD in economics from the University of Rochester.

[Charles W. Calomiris](#) is the Henry Kaufman Professor of Financial Institutions at Columbia Business School, director of the business school's Program for Financial Studies and its Initiative on Finance and Growth in Emerging Markets, and a professor at Columbia's School of International and Public Affairs. His research spans the areas of banking, corporate finance, financial history, and monetary economics. He is a distinguished visiting fellow at the Hoover Institution, a fellow at the Manhattan Institute, a member of the Shadow Open Market Committee and the Financial Economists' Roundtable, and a research associate at the National Bureau of Economic Research. Calomiris is past president of the International Atlantic Economic Society and has served on numerous committees, including the Advisory Scientific Committee of the European Systemic Risk Board, the US Congress's International Financial Institution Advisory Commission, the Shadow Financial Regulatory Committee, and the Federal Reserve System's Centennial Advisory Committee. He also serves as co-managing editor of the *Journal of Financial Intermediation*. He received a BA in economics from Yale University, magna cum laude, and a PhD in economics from Stanford University. Calomiris holds an honorary doctorate from the University of Basel and has received numerous awards and research grants. His most recent book (with Stephen Haber), *Fragile by Design: The Political Origins of Banking Crises and Scarce Credit* (Princeton 2014), received the American Publishers 2015 Award for the best book in business, finance, and management and was named one of the best economics books of 2014 by the *Financial Times* and one of the best books of 2014 by the *Times Higher Education Supplement* and *Bloomberg Businessweek*.

[Christopher DeMuth Sr.](#) is a distinguished fellow at the Hudson Institute in Washington, DC. He was president of the American Enterprise Institute for Public Policy Research from 1986 to 2008 and D.C. Searle Senior Fellow at AEI from 2008 to 2011. A graduate of the Lawrenceville School, Harvard College, and the University of Chicago Law School, DeMuth was staff assistant to President Richard Nixon in 1969–70, working on urban and environmental policy and, during President Ronald Reagan's first term, was administrator for information and regulatory affairs in the Office of Management and Budget and executive director of the Presidential Task Force on Regulatory Relief. From 1976 to 1980, he taught at the Harvard Kennedy School of Government

and directed the Harvard Faculty Project on Regulation. He has also practiced law (with Sidley & Austin in Chicago and at the Consolidated Rail Corporation in Philadelphia), been an economic consultant (with Lexecon, Inc.), and for a time was publisher and editor in chief of *Regulation* magazine (now published by the Cato Institute). He is currently a director of State Farm Mutual Automobile Insurance Company and of several nonprofit organizations.

Harold Furchtgott-Roth is a senior fellow at the Hudson Institute and founder and director of the Center for the Economics of the Internet. He also founded Furchtgott-Roth Economic Enterprises, an economic consulting firm, in 2003. He is the author or coauthor of four books and frequently comments on issues related to the communications sector of the economy. From 1997 through 2001, Furchtgott-Roth served as a commissioner of the Federal Communications Commission (FCC). Before his appointment to the FCC, he was chief economist for the House Committee on Commerce and a principal staff member on the Telecommunications Act of 1996. Earlier in his career he was a senior economist with Economists Incorporated and a research analyst with the Center for Naval Analyses. He received a PhD in economics from Stanford and an SB in economics from MIT.

Michael S. Greve is a professor of law at the Antonin Scalia Law School, where he teaches constitutional law, administrative law, and federal courts. Before joining the law school in 2012, he served as the John G. Searle Scholar at the American Enterprise Institute (AEI), where he specialized in constitutional law, courts, and business regulation. Before joining AEI, Greve was founder and codirector of the Center for Individual Rights, a public interest law firm specializing in constitutional litigation. He has also served as an adjunct or visiting professor at Cornell, Johns Hopkins University, and Boston College. He was awarded a PhD and an MA in government by Cornell University. A prolific writer, Greve is the author of numerous scholarly articles and nine books, including *The Upside-Down Constitution* (Harvard University Press, 2012).

Allan Meltzer is a distinguished visiting fellow at the Hoover Institution and the Allan H. Meltzer University Professor of Political Economy at the Tepper School of Business at Carnegie Mellon University. He has been a visiting professor at Harvard, the University of Chicago, the University of Rochester, the Yugoslav Institute for Economic Research, the Austrian Institute for Advanced Study, the Getulio Vargas Foundation in Rio de Janeiro, and the City University, London. He has served as a consultant for several congressional committees, the President's Council of Economic Advisers, the US Treasury Department, the Board of Governors of the Federal Reserve System, the World Bank, foreign governments, and central banks. He has been a member of the President's Economic Policy Advisory Board. In 1988–89, he was an acting member of the President's Council of Economic Advisers. From 1986 to 2002, he was an honorary adviser to the Institute for Monetary and Economic Studies of the Bank of Japan. In 1999–2000, he served as chairman of the International Financial Institution Advisory Commission, known as the Meltzer Commission, which proposed major reforms of the International Monetary Fund and the development banks. Meltzer's writings have appeared in numerous journals; his most recent publication is *Why Capitalism?* (Oxford University Press, 2012). He has authored several other books, including *A History of the Federal Reserve* (University of Chicago Press, 2 volumes, 2003 and 2009) and numerous papers on economic theory and policy. His career includes experience as a self-employed businessman, management adviser, and consultant to banks and financial institutions. In 1983 Meltzer received a medal for distinguished professional achievement from the University of California at Los Angeles. He was named the distinguished fellow for 2011 by the American Council for Capital Formation and is a distinguished fellow of the



American Economic Association. In 2003 he received the Irving Kristol Award from the American Enterprise Institute and the Adam Smith Award from the National Association for Business Economics. In 2009 he received the Distinguished Teacher Award from the International Mensa Foundation. In 2011 Meltzer received the Bradley Award, the Harry Truman Medal for Public Policy, and the Truman Medal for Economic Policy.
